    - Purchase of new extrication equipment from Extrication Concepts – quote for \$54,082.00
    - Discussion that \$40K was set aside for tools for the new rescue
    - Need to ensure with vendor that there are two batteries and bank chargers for each tool as it's not stated on the quote.
    - Approval to purchase + carry over the difference.
    - 1<sup>st</sup> motion by Dusty, 2<sup>nd</sup> motion by Bill – none opposed.

- New washer and dryer – need to get hooked up to power. Dusty noted that Kenny King will be around soon to take care of.

- Bill –
  - Noted there are three G3 pagers not working – will have work done by KJBL.
  - Noted have quite a few hi-band radios.
  - Noted a request to have a county portable radio in 2713. Discussion that it's not needed.
  - SCBAs to be checked on November 12<sup>th</sup> by MES. There are two OOS. Hope to get five new ones, have eight total + try to have the older ones fixed, if possible.
  - SOGs update – spoke with Peter regarding the status of typing the document. Discussion to ask for all documents back from him so the project can be completed.
  - EMS responses to calls – discussion about personnel and the fly car. It was noted this is being handled by the SFD Board of Directors.

  - Noted that Andrea will be providing grant status and information to him.
  - DEC VFA Grant – discussion about grant – award \$2500 / match \$2500. Andrea had applied for twelve hi-band radios to be awarded by 12/31/25. Tim is working with the DEC regarding this award and items being purchased.
  - 2761 – noted might be leaving/sold end of this week or beginning of next week.
  - Reviewed with Board the loan application for the new rescue.
  - Discussion to draft a resolution for new truck. Approved – 1<sup>st</sup> motion by Bill, 2<sup>nd</sup> motion by Dusty – none opposed.

- Lucy – discussion about updating the website call logs. Bill noted that he takes care of that now, but has been having technology issues.
- Discussion that Bill's District laptop is having issues and is very slow. Approved to see CJ at Level Up to purchase a new one – 1<sup>st</sup> motion by Dusty, 2<sup>nd</sup> motion by Tim.
- Discussion/updates about sidewalk issues on front apron of firehouse. The Village is not concerned about it, and it's not a District or Department issue to worry about.
